# I. GENERAL INFORMATION

# COMMUNICATION

We encourage parents and guardians to empower their children to resolve, with their teachers, any issues that may arise throughout the year (e.g. late work, missed tests, incomplete homework, etc.). Parents and guardians must encourage them to make an appointment with the teacher (via email) to discuss the matter. This first step will make it possible to resolve the situation and reinforce the student's autonomy. If the situation is not resolved, parents and guardians must encourage their child to speak to his/her/their Assistant Director. The goal is always to promote open and constructive dialogue.

Portal. In addition, weekly messages, as well as AD's Memos, are posted each Friday in the

Parents' Corner on CANVAS.

# II. ACADEMICS

# RULES AND CONDITIONS FOR STUDENT PROMOTION AT VILLA MARIA AND COMPLETION OF HIGH SCHOOL STUDIES

# Cycle 1 (Secondary 1 and 2)

## **Conditions for Student Promotion**

Cycle 1 students at Villa Maria continue their education to a higher grade level and/or in Cycle 2 at Villa Maria if they meet the conditions for academic success defined by the school.

# **Core Subjects**

The core subjects in Cycle 1 are English (language of instruction), French (second language) and Mathematics.

# Conditions under which a student is NOT promoted:

# At the end of the school year, if a student,

• fails three (3) subjects, including at least one core subject, and has an overall average of less than 70%, this will result in departure with **no possibility of re-admission**;

OR

• fails two core subjects and has an overall average of less than 70%, this will result in departure with **no possibility of re-admission**;

OR

• fails three non-core subjects and has an overall average of less than 70%, he/she can continue at Villa Maria with a conditional readmission contract.

# **Summer School:**

- For a core subject in which a student receives a failing mark, the student must pass a summer course to be readmitted to Villa Maria for the following school year.
- If and only if a summer school course is not offered for the subject in which a student received a failing mark, proof of a minimum of 20 hours of tutoring by an organisation recognised by Villa Maria will be required.

#### Secondary 3

#### **Conditions for Student Promotion**

Secondary 3 students continue their education at Villa Maria if they meet the conditions for academic success defined by the school.

# **Core Subject**

The core subjects for Secondary 3 are English (language of instruction), French (second language), Mathematics, Science and Technology and History of Quebec and Canada.

# Conditions under which a student is NOT promoted:

# At the end of the school year, if a student,

• fails three (3) subjects, including at least one core subject, and has an overall average of less than 70%, this will result in departure with **no possibility of re-admission**;

OR

• fails two core subjects and has an overall average of less than 70%, this will result in departure with **no possibility of readmission**.

# **Summer School:**

- For a core subject in which a student receives a failing mark, the student must pass a summer course to be readmitted to Villa Maria for the following school year.
- If a summer course is not offered for the subject in which a student received a failing mark, proof of a minimum of 20 hours of tutoring by an organisation recognised by Villa Maria will be required.
- If a student fails the *History of Quebec and Canada* or *Science and Technology* courses, and if and only if a summer school course is not offered for the failed subject, he or she must complete 20 hours of tutoring through an organisation recognized by Villa Maria.

# Secondary 4

# **Conditions for Student Promotion**

Secondary 4 students continue their education at Villa Maria if they meet the conditions for academic success defined by the school.

## **Core Subjects**

The core subjects for Secondary 4 are English Language Arts, French (second language), Mathematics, Science and Technology and History of Quebec and Canada.

In addition to passing English Language Arts and French as a Second Language, Secondary 4 students must pass all the subjects in which a ministerial exam is required, i.e. Mathematics, Science and Technology, History of Quebec and Canada, as well as their art course option.

The Quebec Ministry of Education's *Record of Achievement in Secondary School*, published in July 2023, provides the final verdict on whether a student achieves success in a course.

Situations that hinder a student's academic progress at Villa Maria towards Secondary 5:

# At the end of the school year, if a student,

• fails three (3) subjects, including at least one core subject, and has an overall average of less than 70%, this will result in departure with **no possibility of re-admission**;

OR

• fails two core subjects and has an overall average of less than 70%, this will result in departure with **no possibility of readmission**.

#### **Summer School:**

- For a core subject in which a student receives a failing mark, the student must pass a summer course to be readmitted to Villa Maria for the following school year.
- A student who fails a subject, for which a ministerial exam is required, must pass the July retest, failing which he/she/they cannot be readmitted to the school.

# Secondary 5

# Requirements for the Secondary School Diploma (SSD)

# To obtain their high school diploma, Secondary 5 students must achieve:

- A minimum of 54 Secondary 4 and 5 credits, including at least 20 recognised Secondary 5 credits;
- A passing grade for the following subjects:
  - Secondary 5 English Language Arts
  - Secondary 4 Mathematics
  - Secondary 5 French as a Second Language
  - Secondary 4 Science and Technology
  - Secondary 4 History of Quebec and Canada
  - Secondary 4 Art Option
  - Secondary 5 Quebec Citizenship and Culture (QCC) OR Physical Education

The MEQ Record of Achievement in Secondary School confirms the successful completion of the course.

Note: Some CEGEPs may have additional requirements depending on the program.

# REPORT CARDS (subject to change depending on government guidelines)

Normally, students receive three report cards and one interim report card per school year (October, November, February and June). Parents/Guardians are invited to meet with the teachers twice a year following the November and February report cards. They are also encouraged to contact the teacher to discuss any concerns throughout the year and to follow up with the school administration if they see that their child is encountering difficulty in any subject.

In secondary 4 and 5, only the *Record of Achievement in Secondary School* published by the MÉQ at the beginning of July confirms whether the student achieved a successful result in the subjects.

#### **EVALUATIONS/TESTS/EXAMINATIONS**

- The <u>school calendar</u> is published before the beginning of the school year.
- No absences are permitted during the formal examination session.
- All students are required to be present on the dates and times of each evaluation or exam period shown on the school calendar.
- Parents/guardians must plan family vacations accordingly.

# SUBMISSION OF CLASS ASSIGNMENTS

All homework needs to be submitted by the deadline set by the teacher. Failure to turn in work on time may result in remedial measures.

#### **HOMEWORK**

Homework refers to all assigned work to be performed out of class (written assignments, projects and studying).

# Homework:

- reinforces understanding of lessons and acquired skills
- develops a strong work ethic, organizational skills and a sense of responsibility

In Secondary 1, each assignment is entered in Studyo by the teacher. From Secondary 2 to Secondary 5, students are responsible for entering their homework. Parents and guardians must check the homework entered and contact teachers via the COBA Portal, if necessary. Parents or guardians should encourage students to develop good work habits. Teachers and the school administration may apply certain measures to ensure the revision or completion of homework.

# **AVAILABILITY**

Teachers offer periods of availability to provide students extra help. A teacher's availability can be found on the Canvas Parent Corner page. Students can participate in these sessions on a voluntary basis or by invitation from the teacher or Assistant Director. The aim of these sessions is to ensure student success.

# **EXTRA-CREDIT COURSES / DISTINCTION PROGRAM**

To be eligible to graduate with Distinction within the Extra-Credit Course Distinction Program, a student must:

- complete 3 extra-credit courses,
- obtain a minimum of 70% in each extra-credit course, and

 maintain a minimum overall average of 80% each year of cycle 2 during which they take an extra-credit course.

Attendance in Extra-Credit courses is mandatory. The parent must inform the teacher of the reason of absence as soon as possible. After 3 consecutive absences from an Extra-Credit course after the permitted withdrawal date will result in a withdrawal from the course and a failing grade on the student's record. Your child's registration will be cancelled and registration fees will not be reimbursed.

# **EXEMPTION FROM PHYSICAL EDUCATION**

**Long-term exemption**: The Assistant Director will analyse the medical certificate in order to authorise the duration of the exemption.

**Single-class exemption**: In any situation where a student is indisposed or unable to participate in his/her Physical Education class, he/she must still be present for attendance in their Physical Education class.

# III. STUDENT LIFE

### **ACTIVITIES**

A variety of athletic, cultural, artistic and social activities are available to students. The school is a member of the Quebec Association of Independent Schools (QAIS), the Greater Montreal Athletic Association (GMAA) and the Réseau du sport étudiant du Québec (RSEQ). In general, students participate in these activities outside regular class times. Should one of these activities interfere with class time, the student is responsible for making up the missed work. Scheduled evaluations take precedence over other activities.

# **ACTIVITIES - OUTSIDE REGULAR SCHOOL HOURS**

Please note that the Villa Maria Rules and Regulations apply when a student participates in school activities outside of regular school hours not supervised by school personnel.

# IV. CODE OF CONDUCT

The school administration reserves the right to adjust the sanctions according to the context, the seriousness of the infractions and the student's file.

Being part of Villa Maria means respecting yourself, others and the environment. While the school will educate and guide students along their journey, it is expected that all students act in a manner that respects the rights and freedom of others as well as adhere in the <u>Safe School Action Plan</u>, School Rules and Regulations, <u>the Technology Use Policy</u>, and <u>The Policy on Academic Integrity</u>. Throughout the school year, the school reserves the right to withdraw certain privileges from students who do not abide by these rules of life. Consequences will be given according to the severity of the actions. In addition, respect for common areas is the responsibility of all students at the school. These areas must be kept clean and free from vandalism.

# **SCHOOL UNIFORM**

At Villa Maria, each student becomes a part of the long and storied history of this 170-year-old institution.

- The wearing of uniforms is an important symbol of pride and belonging to Villa Maria College.
- Each uniform must be identified with the student's full name.
- Students with non-conforming uniforms and shoes may be sent home to correct the situation. The parent

- will be notified when the situation cannot be corrected at school and the student must go home.
- Consequences are given based on the number of dress code violations, demerits will be added to the record based on the recurrence and severity of the violations.

Only items purchased from Unimage are accepted, with the exception of socks and shoes.



#### SYSTEM FOR REINFORCING EXPECTED BEHAVIOURS

In order to promote and maintain a respectful and academic environment, Villa Maria has created a system to reinforce expected behaviors. Positive behaviour is rewarded and any violation of school rules may result in one or more demerits being placed on the student's record.

Secondary 1 students are given a grace period until the end of the first 9-day cycle in September. Therefore, during this period, they will receive warnings and feedback regarding school rules, but demerit points will not be recorded.

# MERITAS POINTS: BEHAVIOURAL RECOGNITION

A behavioural recognition system has been implemented to highlight students' good behaviour. A point system will allow classes to obtain privileges when a student's good behaviour is observed by members of the school community. Respect, perseverance and self-determination are the three highlighted values in our school and we will acknowledge all the students who honour these values.

Students can earn Meritas points for many different reasons, such as actively participating in class, having a positive attitude, demonstrating empathy, good behaviour, being a positive role model and/or leader etc. It should be noted that Meritas points are not only recognition of good behaviour, they can also cancel out demerit points students may accumulate.

#### **DEMERIT POINTS**

The school administration reserves the right to apply disciplinary sanctions (demerits, remedial action, suspensions and expulsions), based on professional judgment, for infractions not listed here. The school administration also reserves the right to modify the consequences listed here based on the severity and circumstances surrounding the offence, which may include conditional readmission or expulsion.

The Assistant Directors reserves the right to suspend a student from classes for investigative purposes in the event of a major or serious infraction.

The following is a list of the behaviours and the demerit points assigned:

# **Ipad**

The iPad is a pedagogical tool that can only be used when the teacher gives instruction to do so. Students can also consult it during breaks.

In the event of multiple iPad infractions by a student, school administration with parental consent, may impose stricter iPad restrictions (iPad Jail) to encourage responsible technology use.

# Cell phones

Students can only use their cell phones in the locker area at lunch, where it is allowed in the cafeteria and in the chapel. If students carry their phone with them, it must be in silent mode, in their backpack, and out of sight.

# **CONSEQUENCES RELATED TO DEMERIT POINTS**

# 10 DEMERITS:

 At the 10-demerit mark, the student meets with the special care counselor and serves one-hour detention after-school or during lunchtime.

#### 20 DEMERITS:

- The accumulation of 20 demerits will result in a detention on a Pedagogical Day.
- The Assistant Director will communicate with the student and his/her/their parent(s)/guardian(s)

## 30 DEMERITS:

- The accumulation of 30 demerits will result in a full, one-day in-school suspension.
- A behaviour contract is established
- The Assistant Director will communicate with the student and his/her/their parent(s)/guardian(s)

# 40 OR MORE DEMERITS:

• The consequence will be determined by the school administration depending on the severity of the infraction(s).

## **MAJOR INFRACTIONS**

The following infractions are considered serious and the interventions, consequences and communication methods are at the discretion of the level administrator. If a behaviour repeats itself or there is accumulation of major infractions, subsequent consequences will be more severe in nature. **Demerit points are not applicable for these infractions.** 

A more detailed explanation of the following infractions can be found below.

# **ALCOHOL AND DRUGS**

The consumption, possession, and/or trafficking of drugs and/or alcohol on school grounds, during class trips and/or school activities are strictly forbidden. Similarly, the possession of any drug, drug residue or alcohol/drug-related paraphernalia is strictly prohibited. A student who comes to school in an inebriated state or under the influence of drugs will also be subject to the sanctions outlined above.

# **SMOKING/VAPING**

In compliance with the Tobacco Act, smoking or vaping in the school and on school grounds is prohibited. Similarly, the possession, distribution, or sale of any smoking or vaping-related paraphernalia is strictly prohibited in the school, on school grounds, on school trips or in other activities organized by Villa Maria. A student who comes to school under the influence of drugs or in a state of intoxication is immediately withdrawn from class. Parents will be contacted, sanctions will be applied and the student will be sent home. Consequences will be given at the discretion of the Assistant director.

# **SKIPPING CLASSES**

An unsubstantiated absence from any class, including 1<sup>st</sup> period, is forbidden. Consequences will be given at the discretion of the Assistant Director. The student will be required to make up the time in detention the same day. The student is also responsible for making up any missed classes.

# **INAPPROPRIATE MATERIALS**

Inappropriate and/or illegal materials/objects will be confiscated, and immediate disciplinary measures will be taken that may include communication with the Police. Examples of articles not permitted on school grounds are: matches, lighters, sharp or pointed instruments, lasers, firecrackers, fireworks. Skateboards are not to be used on school grounds.

#### FRAUD AND USE OF FORGERIES

Forging the signature of a parent, guardian, teacher, member of the Administration or another student is prohibited.

# BULLYING / HARASSMENT / VIOLENCE / DISCRIMINATION

Bullying, harassment and violence of a physical, sexual, verbal or psychological nature are prohibited, as well as any form of discrimination, as stipulated in Villa Maria's Bullying and Violence Prevention and Intervention Plan (see <u>Safe School Action Plan</u>). Consequences will be given at the discretion of the Assistant director.

# **PLAGIARISM**

For any case of suspected plagiarism and cheating, please refer to the Policy on Academic Integrity.

#### PRIVACY VIOLATION AND UNAUTHORISED PUBLICATIONS

Rules and expectations on this topic are outlined in the <u>Villa Maria Technology Use Policy for Students</u>. Students are not allowed to take a photograph, video or audio recording of a student or staff member without their consent. The posting, reposting, sharing or publication of messages, images, photographs, videos or audio recordings regarding the school, students or staff on social media or public communication platforms (e.g. Internet, Facebook, Twitter, Instagram, Snapchat, text messages, etc.) are prohibited without the permission of the people involved. Public discussion on any social media platform that is detrimental to the reputation of a student, staff member or the school is strictly prohibited.

Any publication that damages the reputation of the school, a member of staff or a student, whether on social networks or in group discussions, is strictly prohibited (please refer to the <u>Safe School Action Plan</u>).

# SCHOOL SAFETY: BEHAVIOUR THAT POSES A RISK

The following actions are strictly prohibited: deliberately setting off fire alarms, using fire extinguishers, using telephones designated for staff in classrooms and corridors and using any other equipment whose use could jeopardise the safety of pupils. Unnecessarily using an emergency exit is prohibited. Consequences will be given at the discretion of the Assistant Director depending on the severity of the action.

# **VANDALISM**

Any student(s) guilty of defacing or damaging school property or other people's personal property will receive a sanction commensurate with the offence and will be required to pay for the damages incurred and/or engage in restorative justice. Consequences will be given at the discretion of the Assistant Director depending on the severity of the action.

# **STEALING**

Any form of theft will be dealt with in accordance with the law and may lead to police involvement.

# **WEAPONS**

Any student who brings a weapon to school or threatens to use a weapon will be subject to immediate suspension and possible expulsion. Weapons include, but are not limited to the following list: guns, knives, chains, sharp or pointed instruments.

Replica items that are representative and can be deemed "fake" or a "toy" (example: plastic guns, hard plastic large knives, alcohol bottles in shape, etc..) are also not permitted and will be subject to immediate consequences.

# **FOOD AND BEVERAGES**

Only reusable water bottles may be used in class. Water fountains are available for refilling reusable water bottles.

# STUDENT ID CARD

Every student must have their student ID card in their possession as it can be requested at any time. In the event of loss, a replacement ID card will be issued with a replacement fee.

# **LOST AND FOUND**

The school is not responsible for lost or stolen objects. However, it provides students with a lock for their locker at the beginning of the school year. Students are expected to keep their lockers locked at all times to ensure the security of their personal effects in their assigned locker.

For physical education classes, students are responsible for obtaining their own lock. They must lock their locker in the gym locker rooms.

There are two "lost and found" drop-off points:

- Locker room (office of student supervisors)
- Multimedia (iPads only)

# SALE OF ITEMS IN THE SCHOOL

The sale of items in the school (e.g. chocolate bars, raffle tickets) must be authorized by the school administration (Assistant Director).

# **LOCKER ROOM**

The school monitor's office is located in the locker room. This is where lost items and where early or late dismissal slips are issued to students.
